Course objective:

This course will provide students with an introduction and overview of the processes for managing fisheries in a variety of environments. The course will cover the basics of fish biology, ecology and management, with an emphasis on public involvement. Students will gain an understanding of quantitative fisheries methods, including population dynamics and management strategy evaluation, and presentation of scientific information in both written and spoken form. Students will be expected to think critically, apply scientific method, and recognize the limitations of techniques and explore solutions.

Required materials: There is no assigned textbook for this class but supplemental reading materials will be posted on Oncourse and/or emailed. Please read these materials as they will be used in class as discussion topics and there content will be included in tests.
