**Course Description:** Wildlife Techniques is designed to provide students interested in wildlife management with a broad overview of the methods and tools used by wildlife professionals. We will discuss the weaknesses and strengths of each technique and evaluate the choices we make when we utilize a toolset. By the end of the semester, students will have been exposed to a suite of wildlife management tools and will be able to think critically about how and why these tools are employed.

**Course Context:** E461 is an elective course in the O'Neill BSPA, the O'Neill/COAS BSES, and the O'Neill/COAS BAESS. The corresponding graduate course, E561, is an elective course in the O'Neill MSES and MES programs.

**Prerequisites:** SPEA-E 272 or H 316 (undergraduates only); any biology course (all students)

**Required Text:** All text will be provided in PDF format.

## **Broad Learning Outcomes:**

- Students will be familiar with a variety of fish and wildlife management techniques.
- Students will have the ability to choose the appropriate fish and wildlife management tools based on species characteristics and desired outcomes.

**Practical Exams:** Details for exams will be provided in class.

**Field Journal Notes:** In the wildlife field, it is important to take meticulous notes. For this class, your journal will include an entry for each class. Each day will be broken up into two sections: 1) An overview of what was learned during class and 2) your reflection about what was learned.

**Participation and Attendance:** All undergraduate students are allowed to miss one class period without penalty, provided they can demonstrate that they read the literature assigned for that day. Participation grades for undergraduates will be based on asking questions, responding to questions, or visiting your professors during office hours.

**Mentorship and Leadership:** An important component of succeeding as a graduate student is developing the ability to communicate clearly and to teach others. Graduate students will be expected to mentor undergraduate students during field activities and be excellent leaders by setting good examples.

**Fieldwork Participation:** Several classes will require work outside of the lab. Participation in these field events is critical to understanding the techniques covered in class. Each student will be graded on their general willingness to engage with fieldwork activities.

**Final Project:** Details of this project will be covered in class.
