Course Description: The fiscal role of government in a mixed economy; sources of public revenue and credit; administrative, political, and institutional aspects of the budget and the budgetary process; problems and trends in intergovernmental fiscal relations.

Learning Outcomes:

- Understand the revenues and expenditures of operating a local unit of government
- Be able to put together a budget and administer the budgeting process
- Learn about the principals and methodology of different budgeting types (i.e. Priority Based Budgeting (PBB, Incremental Budgeting, Zero-Based Budgeting, etc)
- Understand how to calculate and explain the how taxes are generated to either an elected official, appointed official, and/or community resident or taxpayer
- Be able to understand, analyze, and explain key concepts of a financial statements
- Grasp the interrelationship of non-profits, state, county, and other governments as it pertains to municipal budgeting and financing
- Understand debt management, long-term capital planning, pensions, and investments
- Learn the benefits of incorporating social equity and justice and community participation into the budgeting process

For International Students

This course focuses on economic development trends, conditions, and policies in the United States. Although they might need to be modified to reflect another country's political, economic, or legal requirements, the principles and strategies are applicable in many places. Therefore, you should feel comfortable adapting assignments to your home nation's economic and cultural norms or pointing out that the lessons learned may not be fully transferable. I welcome your suggestions on adapting this course to your needs and circumstances.

Weekly assignments

Each week you'll be asked to respond to between 1-4 exercises, assignments, and/or case study questions that will be posted onto Canvas or onto a discussion thread of which you'll be asked to respond to the question.

All assignments must comply with APA style guidelines, and shall adhere to rigorous professional writing standards, including but not limited to the lack of any spelling, punctuation, or grammatical errors. The default format is times new roman with a 12 point font.

Assignment descriptions and grading rubrics for each assignment are posted on Canvas,

Midterm

You are to write out 4-6 memo, along with any appropriate attachments (single spaced with 12 point font) as if you were a new City Administrator of Finance Director explaining to your council about the upcoming budget process and cycle, highlight trends in the budget (from past years), and explain your approach to handling the upcoming budget.

Final

A short paper will be due, and will constitute 20% of the final grade. The paper must deal with an issue involving budget process and procedure, public expenditure management, and/or public revenue policy, taxation, tax administration, public debt, public pensions, or intergovernmental and non-profit interrelations with local budgeting.

Papers should be in the form of memos addressed to the instructor, 10-20 pages, and typed double-spaced using an 12-point font, with standard 11/4-inch margins.

You should employ and reference books and academic journal articles on your approved topic. You may use any book in the university library, but articles may come from well-established academic journals, all of which are available with full text through the library. In your lit review you should attempt to review or cite at least a minimum of 3 peer-reviewed academic journal.

You may also use official documents produced by the Congressional Budget Office (CBO), Office of Management & Budget (OMB), Congressional Research Service (CRS), the Bureau of Public Debt, and the U.S. Department of the Treasury . Documents and data from various "think tanks" are permitted, such as The Brookings Institution, American Enterprise Institute (AEI),

Heritage Foundation, Urban Institute, Cato Institute and the Center on Budget Priorities. Finally, you may employ documents and data from the National Taxpayers Association (NTA), National Association of State Budget Officers (NASBO), National Council of State Legislatures (NCSL), National Governors Association (NGA), Government Finance Officers Association (GFOA), and International City/County Managers Association (ICMA).

All work must be properly cited.

You must provide the instructor with a one-half page summary of your proposed topic no later than five weeks before the final paper is due, so that the appropriateness of the topic can be evaluated in plenty of time for you to complete the papers. Additional information on the final assignment will be posted onto Canvas.

Budget workshop

You will be expected to attend no less then two budget workshops of a city council, and provide a brief 2 page memo on the experience. Additional information on the midterm assignment will be posted onto Canvas.
