Course Description:

This course will introduce students to the wide variety of ways in which sustainability can be rigorously assessed, calculated, and communicated. This will include conceptual strategies, such as supply chain and life cycle analysis, specific techniques, such as greenhouse gas inventories and energy audits, and associated certification and reporting frameworks, such as LEED and Fair Trade. The emphasis will be on real-world questions and situations, and students will work with sustainability professionals and local organizations to prepare sustainability reports for common consumer goods and services. There are no prerequisites for this course, but students will be expected to have—or to obtain quickly—a working level of comfort with quantitative analysis and presentation, interpersonal and communications skills, and a variety of scientific concepts.

Learning Outcomes:

In this course, students will:

- 1) Develop a critical understanding of the concepts and tools that allow for the assessment of social, economic, and environmental aspects of sustainability
- 2) Conduct and communicate novel sustainability assessments of common consumer goods and services, with recognition of a diversity of values and perspectives
- 3) Actively prepare for a sustainability-related career that integrates individual goals and characteristics with a critical understanding of theoretical and practical considerations

Course Materials:

There is no textbook for this course, but you will be expected to read academic publications, industry publications, and anything else that might be relevant. These will posted to Canvas.

Course Requirements: (% of final grade)

1) Weekly Assignments – (30%)

These will include readings, quantitative problem sets, and other assignments, often related to field trips and guest lectures.

2) Job preparation (25%)

Students will select a specific "sustainability analyst" or similar job, and produce a cover letter, detailed interview notes, and a more formal report on certifications, reporting standards, and key issues facing the associated industry or issue.

3) Consumer Sustainability Reports (25%)

Students will work in small groups to develop reports about the sustainability options related to common consumer goods and services—houses, cars, meat and diary products, clothes, restaurants, etc—in association with local businesses that represent these products or topics.

4) Participation – (20%)

Attendance is necessary but not sufficient—active participation in class discussion and group work is critical for this course (just as it will be for any job you will have after this course...)

A + = 97-100%, A = 93-96.9%, A - = 90-92.9%, etc.

Class Policies:

Class Conduct

I like to maintain a relatively informal atmosphere throughout this class, but I insist that you be respectful to your classmates and any guests (I can fend for myself if you want to test me). Failure to do so will be reflected in your participation grade and could lead to further action.

Attendance

I will not be calling your name at the beginning of each class, but you can expect significant costs to your learning and your final grade if you skip a significant number of classes. Sometimes, however, coming to class is not the best use of your time due to mental health, physical health, mercury in retrograde, etc. A missed class or two will not significantly impact your grade, but talk to me if you start falling further behind.

Late Assignments

In general, every day an assignment is late will result in a 10% penalty (the equivalent of a full letter grade), with a maximum penalty of 50%. This is obviously not an option for some things, such as tests, presentations, and in-class response assignments.

Incompletes and Late Withdrawals

If we get well into the semester and "dire circumstances relating to extended illness or equivalent distress" (IU Enrollment and Student Academic Information Bulletin) prevent you from finishing the class, you have the option to request either an incomplete (I) or a late withdrawal. "An 'I' may be given to a student who, in the judgment of the instructor, has performed at a satisfactory level during a majority of the course but has not completed all the required work by the end of the term due to hardship or other good cause that the instructor deems would make it unjust to penalize that student for not completing the required work on time. After the auto-W deadline, withdrawal will be significantly limited, and you will need permission to withdraw and must meet requirements established by O'Neill." Both of these require a formal petition and a better explanation than simply you were doing poorly in the class. Regarding plagiarism and use of AI:

I am not interested in how other people would answer the assignments. You should certainly draw from other sources and use whatever tools available to find them, but the final submission should be your own. "Borrowing" passages from another text without proper citation is considered plagiarism, and asking someone or something else to generate the text is not much different.
